SINGAPORE TREE CLIMBING CHAMPIONSHIPS (“STCC”) 2011

RULES AND REGULATIONS

1. By taking part in the STCC, you undertake to obey the rules as set out herein and in paragraph 2 below (“the Rules”).
2. The following Rules apply to all events in the STCC 2011 and you shall comply with them:
 - (i) The competition rules of the International Tree Climbing Championships (English version, revised January 2011) by the International Society of Arboriculture. The complete sets of Rules are available at- <http://itcc.isa-arbor.com/rules-scoring/rule.aspx> you will be deemed to have read and familiarized yourself with the Rules and;
 - (ii) To be an eligible participant for Local / Singapore Event Category, you must be (a) a Singapore citizens and Singapore Permanent Residents and; foreign workers holding either Employment pass or; S-pass or; Work-pass and have been living and working in Singapore for twelve (12) consecutive months and; be a member of Singapore Arboriculture Society (SAS) or; International Society of Arboriculture Society (ISA) and (b) must have successfully completed WSQ Basic Tree Climbing Course or; must have competed previously in a STCC or APTCC competition.
 - (iii) a) Competitors competing in the Open / International category shall not be eligible to compete in the STCC Master Challenge. b) Open / International category is open to non-local / international competitors. c) Participants must have successfully completed WSQ Basic Tree Climbing Certificate or an equivalent and / or; d) must have competed previously in a STCC or APTCC competition and / or; e) must be recommended as a worthy competent entrant via written letter from the entrants ISA Chapter, PA or AO body. f) Participants must be a professional member of Singapore Arboriculture Society (SAS) or; International Society of Arboriculture (ISA).
 - (iv) Eligible competitors must complete and submit the official ‘Climber Entry Form and Waiver’ to Singapore Arboriculture Society (SAS) on or prior to the closing date as specified by the STCC 2011 official organizer.
 - (v) Eligible competitors must make full registration payment to Singapore Arboriculture Society prior to the registrations closing date as specified by the STCC 2011 official organizer.
 - (vi) Participants, whom have been selected to qualify for the Asia Pacific Tree Climbing Championship (APTCC) 2011 via STCC 2011, must be a financial member of Singapore Arboriculture Society (SAS) for the current year before being permitted entry into APTCC 2011.
3. The Singapore Arboriculture Society (the “Organiser”) reserve the right to amend the Rules at any time, or to implement any other rules or instructions for the general safety of all participants.
4. You understand and accept that participation in the STCC 2011 may involve certain risks and dangers that may result in serious injury, paralysis, disability or death and you hereby freely and voluntarily assume all risks and undertake responsibility for your own safety during the STCC 2011.
5. You understand and agree that the Organiser and their employees or agents shall not be liable to you or anyone entitled to claim through you for any injury (including death, paralysis or disability) or damage or loss of your property sustained by you, in connection with or in the course of your participation in the STCC 2011, and you hereby waive all your rights against the Organizers.
6. Insurance is provided for each registered participant, for the duration of STCC event held at East Coast Park from 3 to 4 Sep 2011 limited to, Accidental Death S\$25,000, Medical Expense Reimbursement (per any one accident) S\$10,000 and S\$100 for each day of hospital confinement to a maximum of 30 days for lost time from work. It is the sole responsibility of the participant and/or the participant's employer to acquire any additional insurance coverage should they wish to do so.
7. To participate in the STCC 2011:-
 - (i) you must comply with all the requirements in the Rules as stated herein, which are available at www.sas.sg
 - (ii) be sufficiently physically fit to compete safely in this event and you must not have been advised otherwise by a qualified doctor
 - (iii) you must be appropriately attired and wear proper safety and protective gear during the event
 - (iv) agree to the terms of and sign the Disclaimer and Indemnity Form, and;
 - (v) Submit the Application Form together with payment, the Disclaimer and Indemnity Form and the Certification, Waiver and Indemnity Form by Employer all duly completed and signed by the Registration closing date as set out by the official organizers.

Disclaimer of Liability and Indemnity Form

1. I, _____(name), having Passport number _____.
2. I fully recognize and accept that any outdoor activities such as the events in the STCC 2011 that involve substantial and physically testing obstacles may involve certain dangers, including but not limited to the forces of nature, unforeseeable failure of equipment and my own actions; and that participation in the STCC 2011 may be dangerous and involve risks and dangers that may result in serious injury, disability, paralysis or death to myself or other persons participating in the STCC 2011.
3. I declare that I am physically fit and I certify that to the best of my knowledge, I do not have a medical condition which might have the effect of making it more likely that I will be involved in an incident which could result in injury to myself or others.
4. I further declare that my participation in the STCC 2011 is undertaken freely and voluntarily by me at my own risk. I recognize and fully assume all risks and dangers involved in my participation and will not under any circumstances rely on the care, judgment or assurance of anyone other than myself for matters relating to my own safety.
5. I agree that I am responsible for my own safety (and the safety of my possessions) and will not hold the Organiser responsible for the consequences of my participation in the STCC 2011, including any injury (including disability, death or paralysis), damage to or loss of property sustained by me or for any loss, damage, expense or costs sustained by me or arising out of my participation in the STCC 2011.
6. In consideration of the Organiser's acceptance of my application for entry as a participant in the STCC 2011, I hereby
 - (i) declare that I will not hold the Organiser or any of their employees or agents liable for any personal injury to me (including disability, paralysis and death), or property loss or damage (including to my equipment);
 - (ii) waive any and all claims I may have at any time, or any and all claims which might otherwise be made by, or on behalf of, or on account of me, or by any person or entity in any way (whether under the right of subrogation or otherwise), against the Organiser and their employees or agents, howsoever arising on account of or in consequence of my activities or participation in the STCC 2011, or in any other way related to the STCC 2011, whether arising in tort or contract; and
 - (iii) undertake that I will, at all times sufficiently indemnify and keep the Organiser indemnified against any claim, action, loss, costs and expense in respect of personal injuries sustained by me or damage to my property caused by or arising from or in any way related to the STCC 2011.

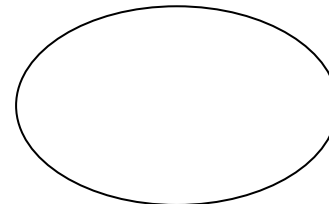
